
Lands Available for Conservation in Pennsylvania Townships That Have Open Space Taxes





February 2022

Summary

Pennsylvania Act 153 of 1996 ("Open Space Lands, Acquisition and Preservation") authorizes local governments (excluding counties) to establish earned income and real estate taxes specifically dedicated to the acquisition of land and easements for the purpose of providing open space benefits. The local governments must receive referendum approval from voters before enacting such taxes.¹

In this report, <u>WeConservePA</u> identifies the quantity of remaining unprotected open space in townships that have passed open space tax referendums. WeConservePA's research addresses a concern that a township might reach buildout—a condition where all available land is either conserved or developed—and thus be unable to use open space taxes for acquisition of real property interests.

WeConservePA found that all 72 municipalities that have passed open space tax referendums have a substantial amount of undeveloped, unprotected land appropriate to conserve. Only one township has fewer than 1,000 acres of large parcels of unprotected open space remaining. Considerably more unprotected open space could be conserved if townships were to look at smaller parcels that could be stitched together into larger conservation tracts.

Data Sources and Methodology

The Trust for Public Land's <u>LandVote</u> tabular database, which covers the years 1988 through the present, tracks open space referendum results across the country. WeConservePA joined its spatial data with LandVote data to create a spatial database of the 72 Pennsylvania municipalities that have passed open space tax referendums.

WeConservePA continually updates its <u>Conserved Land Spatial Database</u>, which identifies publicly and privately conserved land in Pennsylvania. WeConservePA overlaid this conserved land data with tax parcel and land use data for the 72 municipalities to identify large parcels that are neither developed nor conserved. The land use data came from Chesapeake Conservancy's 2013 mapped 1-meter resolution land use classes.

Individual parcels of land containing less than five acres of undeveloped,² unprotected open space were excluded when reporting the total acreage of unprotected open space remaining. This approach understates the amount of land available for conservation in that one can stitch together contiguous parcels of less than 5 acres each in order to conserve a larger area.

¹ In addition to acquiring real property interests, the statute allows up to 25% of open space taxes to be used to:

⁽¹⁾ develop, improve, design, engineer, and maintain open space acquired with dedicated open space taxes and

⁽²⁾ prepare the resource, recreation, or land use plan needed to acquire open space.

² Undeveloped land use categories included tree canopy, low vegetation, shrubland, wetlands, and water.

Additionally, in more highly built communities, parcels of less than five acres may have significant value for water quality, wildlife habitat, and outdoor recreation.

The 19 townships that have only passed bond-based referendums were excluded from the remaining unprotected open space analysis because there is no concern that open space money will accumulate in these townships; bonds provide one-time funding rather than an ongoing revenue source.

Findings

All 72 townships that have passed open space tax referendums have a substantial amount of undeveloped, unprotected land appropriate to conserve. In total, nearly 400,000 acres—617 square miles—of open space remain unprotected. The amount of open space that is not conserved in each municipality varies greatly and is presented in the table that concludes this report.

The mean average unprotected open space in townships with open space taxes is 5,460 acres, with a median of 4,000 acres. Barrett Township in Monroe County has the highest amount of unprotected open space with 23,700 acres or 80% of existing open space.

No township lacks unprotected open space to conserve. Only one township has fewer than 1,000 acres of unprotected open space remaining—Perkiomen Township in Montgomery County. Perkiomen has 711 unprotected acres, constituting 55% of the township's total open space and 23% of its total area. Thirteen townships have from 1,000 to 2,500 acres of open space that remain unprotected.







Figure 2. Spatial representation of remaining acres of unprotected open space by township (for those that have open space taxes)
