Land trusts continue their extraordinary run of conservation work. In 2020 and 2021, Pennsylvania land trusts protected 28,000 acres (40 square miles), roughly the land and water area of the City of Pittsburgh. In the past decade, they expanded on the lands they previously conserved by 34 percent; fully 25.5% of all the conservation they have ever accomplished occurred from January 1, 2012 through December 31, 2021.



These numbers and the other data contained in this report testify to the tremendous, ongoing achievements of land trusts, big and small, across our

Commonwealth. What the census misses but merits attention is that land trusts also face greater complexity when completing their conservation transactions than ever before and that they are building ever-stronger stewardship programs to ensure that their conservation work is lasting. They are also doing much more for the public good: providing 600 miles of recreational trails in their preserves, reforesting stream banks, running educational programs, addressing matters of equity and inclusion, and so on.

As of the beginning of 2022, land trusts have conserved 817,178 acres (1,277 square miles) in Pennsylvania—more land than the area of Cumberland and Dauphin Counties combined. 











CONSOLIDATION IN THE LAND TRUST MOVEMENT



- Heritage Conservancy and Conservancy of Montgomery County (2012)




STAFFING

562 MILES OF ON-PRESERVE, PUBLIC TRAIL

Forty-four Pennsylvania land trusts report managing 562 miles of trail open to the public within their preserves. This number does NOT include their many miles of trails running outside their preserves. It does not include trails that they steward on government-held lands. Nor does it factor in the 151 perpetual trail easements they hold.

Natural Lands is by far the largest manager of on-preserve trails with 109 miles within its preserves. The ten land trusts managing the most on-preserve, public trail are (in ranked order):

Lancaster Conservancy

This is the first census for which WeConservePA collected trail management information for land trusts. This data has not undergone the same level of scrutiny and cross-checking as all the other census data and likely there is missing data; thus, we have chosen not to publish a detailed table at this time.

WHAT IS CONSERVATION?

Conservation is defined by Meriam Webster as "a careful preservation and protection of something, especially planned management of a natural resource to prevent exploitation, destruction, or neglect."

Wikipedia defines it as "the preservation or efficient use of resources..."

Wiktionary's first definition is: "The act of preserving, guarding, or protecting; the keeping (of a thing) in a safe or entire state; preservation." Its second definition is: "Wise use of natural resources."

National Geographic's encyclopedic entry defines it as "the act of protecting Earth's natural resources for current and future generations."

The entry continues:

Earth's natural resources include air, minerals, plants, soil, water, and wildlife. Conservation is the care and protection of these resources so that they can persist for future generations. It includes maintaining diversity of species, genes, and ecosystems, as well as functions of the environment, such as nutrient cycling.

Conservation is similar to preservation, but while both relate to the protection of nature, they strive to accomplish this task in different ways. Conservation seeks the sustainable use of nature by humans, for activities such as hunting, logging, or mining, while preservation means protecting nature from human use.



WeConservePA uses conservation to mean taking action to ensure for present and future generations some or all of the following outcomes:

- The land will serve as natural infrastructure: absorbing rainwater to prevent erosion and flooding and recharge groundwater; filtering stormwater runoff of pollutants before they can enter waterways; and sequestering carbon in plants and soil.
- The land will be available and productive for logging, farming, hunting, and other activities that sustainably draw from nature.
- The land will provide habitat and support the diverse species with which we share the planet.
- The land will provide other open space benefits such as scenic views and opportunities for recreation, reflection, and inspiration.

WeConservePA also looks at conservation encompassing the active stewardship of land (for example, fencing forest to prevent deer overbrowse or redesigning trails to prevent stormwater runoff) and the active restoration of natural functions to degraded lands and waters (for example, reforesting riparian areas or establishing meadow on strip mined land). Even more broadly, conservation describes actions to live sustainably to ensure that future generations may enjoy nature, undiminished.
