3. Medical Treatment. I hereby release and forever discharge Habitat from any claim whatsoever which arises or may hereafte arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tim with Habitat.
4. Assumption of the Risk. I understand that my time with Habitat may include activities that may be hazardous to me including, but not limited to, construction activities, loading and unloading of heavy equipment and materials, and local transportation to and from the work sites. I hereby expressly and specifically assume the risk of injury or harm in these activities and release Habitat from all liability for injury, illness, death, or property damage resulting from the activities of my time with Habitat.
